NOW, THEREFORE, BE IT RESOLVED, that the attached lists of nominees be approved as “election officials” for the Town of Sevastopol, for the term beginning January 1, 2014 and ending December 31, 2015, and said election officials shall file such oath of office, as required, within ten (10) days of receiving said notice of appointment by the Clerk.






