ORDINANCE NO. 05 – 2016

An Ordinance Regulating Standing, Loading, and Parking on Town Roads

The Town Board of the Town of Sevastopol, Door County, Wisconsin, pursuant to Wisconsin State Statutes, Sections 346.50, 346.52, and 346.55, does hereby ordain as follows:

Section 1 – Purpose

To enact an ordinance regulating standing, loading, and parking on town roads located in the Town of Sevastopol, Door County, Wisconsin, in order to provide for the proper use of the roadways for the health, safety, and protection of the users.

Section 2 – Definitions

Person – Means and includes any individual, firm, corporation, and association, and partnership, co-operative or governmental agency.

Motor Vehicle – means any automobile, motorcycle, truck, trailer, semitrailer, truck tractor and semitrailer combination, or any other vehicle operated over the town roads used to transport persons or property and propelled by power other than muscular power.

Semitrailer – means any wheeled vehicle without motive power, designed for use with a truck tractor, used to carry and transport cargo or property over town roads and public highways.

Residential Street/Roads – means those streets/roads whose primary function is to provide access to immediately adjacent land used for single-family or multifamily residential purposes.

Section 3 – General Parking Prohibitions

- 1 - In front of a public or private driveway
- 2 - Within an intersection
- 3 - In a manner that blocks traffic or interferes with or blocks the passage of other vehicles.
- 4 - At any place where official signs prohibit parking

Section 4 – Leaving Motor Vehicle on Pave, Improved, or Main-traveled Portion of Roads

No person shall leave standing any vehicle, attended or unattended, upon the paved, improved or main-traveled portion of any street when it is practicable to leave such vehicle standing off of paved, improved or main-traveled portion of such road.

If not practicable to leave motor vehicle off of paved, improved or main-traveled portion of street/road, hazard light need to be on both the back and front of the motor vehicle so oncoming traffic can see parked motor vehicle.

Section 5 – Penalties

1 – Any person violating any provision of this ordinance for the first offense shall be fined not less than \$50.00 nor more than \$100.00.

2 – Any person violating any provision of this ordinance for a second offense shall be fined not less than \$100.00 nor more than \$200.00.

3 – A separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

Section 6 – Enforcement

1 – This ordinance may be enforced by the issuance of a citation to any violator of this ordinance by any Sheriff or Deputy Sheriff of the County of Door, State of Wisconsin, by any State of Wisconsin officer with police powers, or by the Town Constable of the Town of Sevastopol or any other duly employed law enforcement officer of the Town of Sevastopol.

2 – In the alternative, any forfeitures imposed by this ordinance may be sued for and recovered pursuant to Chapter 778, Wis. Stats., in the name of the Town of Sevastopol.

Section 7 – Conflicting Ordinance

All ordinances in whole or in part of the Town of Sevastopol which conflict with the provisions of this ordinance, that portion will be repealed.


This ordinance shall take effect on the day after its publication.
