# TOWN OF SEVASTOPOL ORDINANCE NO. 02-2016

# An Ordinance Regulating Activities in the Town of Sevastopol Parks

The Town Board of the Town of Sevastopol, Door County, Wisconsin, pursuant to Wisconsin State Statutes, Sections 60.22 and 61.34, does hereby ordain as follows:

#### **Section 1 - Purpose**

To enact an ordinance regulating activities in the town parks located in the Town of Sevastopol, Door County, Wisconsin, in order to provide for the proper use and enjoyment of the parks by users and for the health, safety and protection of the users.

# **Section 2 - Definitions**

Person – means and includes any individual, firm, corporation, and association, and partnership, co-operative or governmental agency.

Refuse –means all solid wastes including garbage, rubbish and trash.

Prohibited Refuse – means hazardous wastes, dead animals, solid wastes required by law to be recycled and all liquid waste.

Refuse Container – means those containers used for the disposal of refuse located in the Town Parks

Town Parks – means the park(s) located in the Town of Sevastopol, Door County, Wisconsin owned by the Town of Sevastopol and posted as town parks. This ordinance is intended to apply to the present town parks, which consist of the town park located on State Highway 57, south of Sevastopol school, and the park located on South Lake Drive on Clark Lake, and all future town parks.

## **Section 3 – Alcoholic Beverages**

Alcoholic beverages may be consumed by persons in the town parks during park hours only.

#### Section 4 – Animals

No dogs, other pet animals, or other animals are allowed in any town park at any time. Service animals specifically trained to aid a person with a disability are welcome.

## Section 5 – Disorderly Conduct

- 1 No person while in a town park shall engage in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct.
- 2 "Violent" or "abusive conduct" includes conduct by a person threatening, quarreling, or challenging another person to fight or fighting, or likely to provoke another to fight.

#### Section 6 – Fires

- 1 No fire may be made, started or continued in any town park expect in grills or pits designated for such purposes.
- 2 All such fires allowed under this section shall be extinguished before leaving the park.

#### Section 7 – Glass Bottles

No person may possess or use, or permit others to possess or use, any glass bottles in any town park.

## Section 8 - Park Hours

- 1 The park on South Lake Drive on Clark Lake (swimming beach) is open daily from 6 a.m. to 9 p.m. No person shall remain in this town park between the hours of 9:01 p.m. and 5:59 a.m.
- 2 The Town Park, located on State Highway 57, south of Sevastopol School is open daily from 6:00 a.m. to 11:00 p.m. No person shall remain in this town park between the hours of 11:01 p.m. and 5:59 a.m.
- 3 Whitefish Bay boat launch, located at the end of Whitefish Bay Road. Follow the posted guideline at the launch.

#### Section 9 – Vehicles/Parking

No person shall operate or park any type of motor vehicle, motorcycle, bicycle or allterrain vehicle in any park except on roads or parking areas designated for that purpose, expect for maintenance and delivery vehicles.

#### Section 10 – Refuse

1 – No person shall cause any type of refuse or prohibited refuse to be littered or otherwise strewn, in any town park.

- 2 All refuse from use of a park shall be placed in the refuse containers located in that park.
- 3 No person shall place, or permit others to place, any refuse in any container located in a town park, unless the refuse is from that park.
- 4 No person shall place, or permit others to place, any prohibited refuse in any refuse container located in any town park, whether or not the refuse is from the park.

#### Section 11 - Snowmobiles

- 1 No snowmobiles are allowed at any time in the Town Park on Clark Lake.
- 2 No snowmobiles shall be operated in the Town Park on Highway 57.
- 3 No snowmobiles shall be parked on any designated trail so as to block the flow of traffic on that trail.

# Section 12 – Use of Parks by Groups

- 1 Any group of individuals who wish to use the Town Park, located on State Highway 57 for regular athletic events, such as softball, or baseball games, or who wishes to use the pavilion for large family gatherings, company picnics, meetings, or other such events, shall first obtain the written permission of the Park and Rec. Board.
- 2 A person duly authorized by such group to do so, shall execute any application, agreement or other documents required by the Park and Rec. Board for such use of the park along with a deposit to use the park. Fee to use the park is set by the Park and Rec Board.

#### Section 13 – Penalties

- 1 Any person violating any provision of this Ordinance for a first offense shall be fined not less than \$20.00 nor more than \$40.00.
- 2 Any person violating any provision of this ordinance for a second offense shall be fined not less than \$50.00 nor more than \$100.00.
- 3 A separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

#### **Section 14 – Enforcement**

1 – This ordinance may be enforced by the issuance of a citation to any violator of this ordinance by any Sheriff or Deputy Sheriff of the County of Door, State of Wisconsin,

by any State of Wisconsin officer with police powers, or by the Town Constable of the Town of Sevastopol or any other duly employed law enforcement officer of the Town of Sevastopol.

2 – In the alternative, any forfeitures imposed by this ordinance may be sued for and recovered pursuant to Chapter 778, Wis. Stats., in the name of the Town of Sevastopol.

# Section 15 - Conflicting Ordinance

All ordinances in whole or in part of the Town of Sevastopol which conflict with the provisions of this Ordinance that portion will be repealed.

This ordinance shall take effect on the day after its publication.
